### **OWNER/MEMBER REQUIREMENTS:**

1. Warranty deed (if your deed is not in your closing packet, print the information from the Orange County Property Appraiser, OCPA).
2. Membership (contact) application
3. Key fob application for owners
4. Valid ID

\*\*The owner will be issued the first key fob once application and the \$15.00 payment are received.

- IF YOU, THE OWNER, DO NOT HAVE ALL OF THE REQUIRED INFORMATION, IT IS YOUR RESPONSIBILITY TO OBTAIN IT IN ORDER TO HAVE ACCESS TO THE AMENITIES.
- If a faulty key fob is turned in (system is unable to read them), the key fob will be replaced for the member/renter free of charge.
- If a key fob is damaged, the owner/renter must pay for a replacement.
- If a lease has expired, the owner must submit a current lease. You will not have to pay for another key fob; you only need to request for the key fob to be reactivated.
